# **WAIVER AND RELEASE OF LIABILITY**

In consideration of my child ("Participant") being allowed to participate in any way in Bellingham Bells Bat Kids promotions related events and activities, the undersigned, for and on behalf of myself, any other parent/guardian, and the Participant:

1. Acknowledge and fully understand that the Participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions, or negligence but the action, inaction, and negligence of others, or the condition of the premises or of any equipment used. Further, that the parent/guardian and any other child or guest under his/her supervision who is attending/watching a game assumes risks from thrown or batted balls, bats or any other objects on or leaving the field, and the risks of being injured by the acts of others, and other risks incident to baseball and baseball game activities, and that there may be other risks not known or not reasonably foreseeable at this time.
2. Assume all the foregoing risks, including risks from thrown or batted balls, bats or any other objects on or leaving the field, and the risks of being injured by the acts of others, and other risks incident to baseball and baseball game activities, and accept personal responsibility for the damages following such injury, permanent disability or death.
3. Covenant not to sue, and release, waive and discharge the Bellingham Baseball Club, LLC, Sandlot Ventures, LLC, and all individuals, members, managers, employees, volunteers, and entities affiliated with these entities in any way, West Coast League, Industrial Credit Union ("ICU"), Bellingham Parks & Recreation, City of Bellingham, and all of the respective administrators, directors, agents, members and other employees of all the organizations named in this Section 3, other participants, sponsoring agencies, sponsors, advertisers and, if applicable, owners and lessors of premises used to conduct the event, all of which are hereinafter referred to as "releasees," from any and all liability to the undersigned and participant, his or her heirs, assigns, and next of kin from any and all claims, demands, losses or damages of any kind on account of any injury, including death and damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise.

Neither my child nor I are aware of any reason, medical or otherwise, why he/she should not participate in Bellingham Bells Bat Kids promotions related events and activities, and we are prepared to, and do, hereby accept any and all risks, whether known or unknown to my child and/or me, of having him/her participate. It is further understood and agreed that this Waiver and Release of Liability, and the assumption of risk contained herein, has been freely entered into and is to be binding on our heirs and assigns.
